- 1. Has your company conducted due diligence assessments for the supply chain(s) covering this trade item?
- 2. Has your company mapped the risk of violations of fundamental human rights within the countries and/or regions where the trade item is manufactured, or sources its raw materials from?
- 3. Has your company mapped the risk of violations of fundamental human rights within conflict areas where the trade item is manufactured, or sources its raw materials from?
- 4. Has your company mapped the risk of violations of fundamental human rights connected to the processes of extraction, refining, and processing of raw materials, component manufacturing, or the manufacturing of the trade item itself?
- 5. Does the trade item have relevant third-party verified certifications for socially responsible production?
- 6. Does the trade item have relevant third-party verified certifications for socially responsible production, which includes the final assembly of the trade item?
- 7. Does the trade item have relevant third-party verified certifications for socially responsible production, which include component manufacturing or raw material processing?
- 8. Does the trade item have relevant third-party verified certifications for socially responsible production, which include raw material extraction?
- 9. Does your company have its own ethical guidelines (Code of Conduct), or have received ethical guidelines from customers, which include requirements for compliance with ILO core conventions, the UN Convention on the Rights of the Child, the UN Declaration on the Rights of Persons Belonging to National or Ethnic, Religious, and Linguistic Minorities, ILO Convention 169 on Indigenous and Tribal Peoples' Rights, ILO conventions on decent work, occupational health and safety laws in the countries where the trade item, components of the trade item, or raw materials are manufactured, and the payment of a living wage to workers at production units contributing to the manufacturing of the trade item?
- 10. Does your company have its own requirements for the payment of a living wage to workers at trade itemion units contributing to the manufacturing of the trade item, in accordance with the ILO Decent Work Program?

- 16. Is the extraction of raw materials carried out at production units certified according to the SA8000 International Accord or equivalent, or annually audited with the SMETA 4-Pillar audit or equivalent?
- 17. Does your company have its own procedures to detect, stop, prevent, and reduce negative impact and harm in the trade item's supply chain?
- 18. Does your company have its own procedures for procurement planning, to avoid rush orders and/or sudden order changes, making it possible in practice for suppliers to plan production or estimate production capacity?
- 19. Does your company know whether there are made arrangements for social dialogue and training to ensure that workers at the production units contributing to the manufacturing of the trade item are aware of their rights?
- 20. Does your company have its own guidelines to ensure that production prices are not negotiated below established market prices for the trade item?
